
Sub : COURTS - CIVIL COURT DEPOSITS - INVESTING IN FIXED DEPOSITS WITH IN TIME -Instructions-Issued -Regarding.

Instances have been coming to the notice of the undersigned that due to non investing the Civil Court Deposit amounts in the Fixed Deposits , as per terms of the Decree/Award in M.V.O.P . cases within time, the litigant public are suffering loss of interest . While so, amidst these circumstances, the undersigned is pleased to issue the following instructions:

1. The M.V.O.P. clerk as a part of his duty has to scrutiny the Cheque petitions with absolute responsibility and without any error and issue a copy of Decree/Award to the Accounts Clerk so as to keep the compensation amounts in C.C.D and Fixed Deposits as per terms of Award/Decree.
2. The compensation amounts shall be invested in any interest yielding Fixed deposits in any Nationalized Bank without delay, and appropriate Orders must be obtained from the Presiding Officers by the Accounts section who generally deal with deposits and investments.
3. The Presiding Officers, Chief Ministerial Officer / Senior Superintendent/ Superintendent, Accounts clerk and Bench clerks shall be subjected to equal responsibility in order to draw special attention to avoid **injustice to the parties from loss of interest by timely non-investment as per Hon'ble High Court's circulars in ROC.515/SO/2000 dt. 20.2.2000, ROC.3394/99 OP. Cell -E dt. 26.07.2000 and ROC.3227/91 -B.SPL dt. 05.01.1998 and 26.02.1999**
4. The Accounts clerk should verify the Fixed deposit receipts after investing the compensation amounts in the Banks.

5. Causing necessary entries in the Ledger, Deposit, Cash Book, Repayment, issuing cheques , obtaining initials on the concerned case docket sheet by the Presiding Officer and Superintendent etc., are the chain process of work to complete each case transaction . The Accounts Clerk should get his work scrutinized by the Superintendent before placing the Presiding Officer.
6. The litigant public who are aggrieved in M.V.O.P. cases are submitting the petitions to the Hon'ble High Court of A.P. questioning the loss of interest . The delay has been causing due to inactiveness of the Accounts Clerks, Proper scrutiny by the Superintendents and non affixing of thumb in right time by the Presiding Officers. Everyone should realize that the litigant public in M.V.O.P. Cases have been suffering in every way due to the inattentiveness of the concerned.

In these circumstances, the Judicial officers are requested to bestow their personal attention and to take necessary steps for compliance of the instructions.
