The Chief Judicial Magistrate -cum- Principal Civil Judge (Senior Division), Kurnool shall make necessary in-charge arrangements during the absence of Judicial Magistrates of I Class at their respective Stations in Kurnool District on **29-06-2024**, to enable the Judicial Magistrates of I Class of the Unit to attend Workshop-II on **29-06-2024** at Kurnool.
