### ***NOTIFICATION FOR FILLING UP OF 02 (TWO) VACANCIES OF DISTRICT JUDGE UNDER ACCELERATED RECRUITMENT BY TRANSFER THROUGH LIMITED COMPETITIVE EXAMINATION AMONG THE CIVIL JUDGES (SENIOR DIVISION), WHO HAVE COMPLETED FIVE YEARS OF SERVICE, FOR THE YEAR 2024.***

Applications are invited to fill up 02 (Two) vacancies of District Judge under Accelerated Recruitment by transfer through Limited Competitive Examination among the Civil Judges (Senior Division) who have completed five (05) years of qualifying service in the Andhra Pradesh State Judicial Service as on 31<sup>st</sup> March, 2024. The scale of pay for the post of District Judge is Rs.144840-194660.

#### ***Note:***

The High Court of Andhra Pradesh reserves the right to increase or decrease the number of vacancies or cancel the notification, at any stage, without assigning any reason whatsoever. No right will accrue to the candidate by virtue of the Notification.

The Andhra Pradesh State Judicial (Service and Cadre) Rules, 2007 and Amendments shall be applicable to the recruitment process.

The Civil Judge (Senior Division) who found to be of doubtful integrity in any of the preceding years from the date of notification, and who is facing disciplinary enquiry or has suffered or suffers with any punishment for committing any irregularity in discharge of his/her duties shall not be eligible for appointment under the Accelerated Recruitment by Transfer.

#### **I. SCHEME OF EXAMINATION:**

The process of selection is as follows:-

- a) For the purpose of short-listing the candidates, if any, the High Court will conduct Screening Test for 100 marks comprise of 100 multiple choice objective type Questions. The duration of examination will be two (2) hours. The Venue and Time will be mentioned in the Hall Ticket, to be downloaded by the candidate at an appropriate point of time.

The candidate who secure 40% and above marks in the screening test will be short listed in the ratio of 1:10 of the available vacancies, for the written examination.

Provided that, if there are more than one candidate who have secured identical marks in the screening test, all such candidates shall be called for the written examination.

The marks obtained in the screening test shall not be added to the marks obtained in the written examination and they shall not be counted for determining final order of merit in selection of the candidates, as the screening test is conducted for the purpose of short-listing the candidates.

**Note:** Conduct of Screening Test will depend on, the number of applications received from the aspiring candidates.

- b) Written Examination consist of the following three (3) papers. Each paper will carry 100 marks. The duration of each paper is three (3) hours.

The question/s in the examination shall be answered only in English (except Translation)

I) Constitution and Civil Law

II) Criminal Law

III) English (Translation and Essay writing). Translation test has to be made from English to Telugu and Telugu to English.

The Translation test is conducted for 25 marks and Essay Writing test for 75 marks on Legal Subjects.

## **II. MINIMUM MARKS TO BE SECURED IN WRITTEN EXAMINATION TO BE ELIGIBLE FOR *VIVA VOCE*:**

The candidates, who belong to OC/BC categories shall secure not less than 55% of marks in each paper and not less than 60% of marks in aggregate in written examination.

And the candidates who intend to avail reservation in SC/ST category shall secure, not less than 45% marks in each paper and not less than 50% of marks in aggregate in written examination to eligible for *Viva Voce*.

## **III. *VIVA VOCE*:**

The *Viva Voce* test is for 50 marks. Any candidate who remain absent for the *Viva Voce* will be deemed to have been disqualified for selection.

The successful candidates in written examination will be called for *Viva Voce* in the ratio of 1:3 of the available vacancies, and if there are more than one candidate who have secured identical cut off marks, all such candidates shall be called upon to appear for *Viva Voce*.

No TA and DA will be paid to the candidates appearing Screening Test (if any)/Written Examination/*Viva Voce*.

The decision of High Court as to the eligibility or other wise of a candidate for admission to Screening test (if any), written examination and *Viva Voce* shall be final.

**IV. MINIMUM AGGREGATE MARKS TO BE SECURED IN THE WRITTEN EXAMINATION AND VIVA-VOCE FOR SELECTION TO THE POST OF DISTRICT JUDGE:**

For the selection to the posts of District Judge under Accelerated Recruitment by Transfer, the candidates from OC/BC category shall secure at least 60% marks in aggregate in Written Examination and Viva Voce and the candidates who belong to SC/ST category and intend to avail SC/ST category shall secure at least 50% marks in aggregate in written examination and *Viva Voce*. The candidates who secure less than such percentage of marks will be ineligible for selection to the post.
