In pursuance of the Hon'ble High Court's direction in the ref.3rd above, to submit the category wise vacancies to be filled up by direct recruitment, certain information is required in the categories of Driver and Stenographer Grade-III .

Due to dearth of staff members in the cadre of Stenographers Grade-III and Driver , much inconvenience is causing to the Hon'ble Judges and Court proceedings. Before surrendering vacant posts to the Hon'ble High Court of A.P. in both cadres, the willingness of qualified employees who ever are willing to act as Stenographer Grade-III and Driver (Light Vehicle) with technical qualifications and skills respectively as prescribed below are requested by 01.07.2024 to take further steps in the matter.

For the Post of Stenographer Grade - III

As per Annexure I of Rule 8 of the G.O.Ms. No.76 Law (L,LA & J-Home-courts .A), Department dated 15.5.2019 the requisite Qualification for promotion to the post of Stenographer Grade-III are

- Must be a Graduate from any recognized University and
- Must have passed A.P Govt. technical examination in English Typewriting by Higher grade and
- Must have passed A.P. Govt. Technical examination in English shorthand by Higher grade or equivalent examination.

Provided that if candidates who have passed the examination by Higher grade are not available, those who have passed the examination by the Lower grade to be considered. They must have knowledge or qualification in computer operation.

For the post of Driver:

Amendment is made to Rule-8, category-14 of Annexure-1 of G.O.Ms. No.76 Law (L,LA & J-Home-courts .A), Department dated 15.5.2019, which is substituted as per G.O.Ms.No.151 LAW(LA & J-HOME-COURTS-A) Department , dt.17.10.2022, One

- (1) Must have passed 7th class or equivalent examination .
Candidates who failed intermediate will be considered but those who have higher qualifications than that shall not be considered.
- (2) Must possess a current valid light motor vehicle driving license issued by competent authority under the Motor authority under the Motor Vehicles Act, 1988 with practical experience in driving Motor vehicles for a period of not less than (3) years with endorsement to drive Motor cycle and Auto rickshaw.
