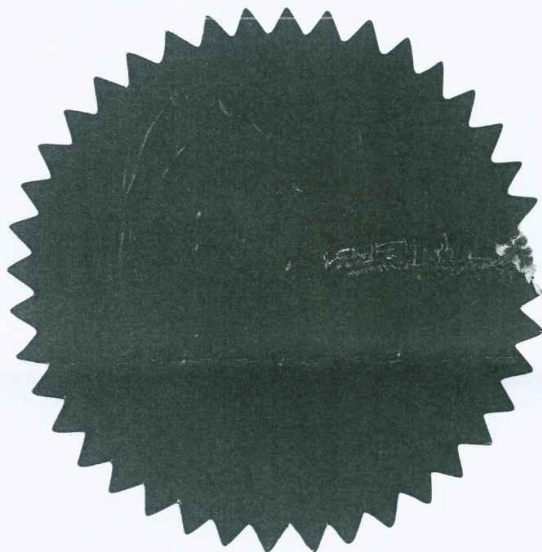

1. The Petitioners are filing the present Special Leave Petition against the impugned order dated 22.11.2023 passed by the Hon'ble High Court of Andhra Pradesh in I.A.
