In pursuance of the references cited supra, to fill up the vacancies in the cadre of Senior Superintendents, the Service Registers, Confidential report and Special Reports were called for, from the eligible candidates i.e., from the cadre of Superintendents and after perusing the confidential files and special reports of the individuals and the instructions laid down in the references cited above, interviews held on 02-09-2024 and the following the Superintendents (Category-3) are selected temporarily promoted to the posts of the Senior Superintendents (Category-2 of APJMSS Rules-2019) and due to shortage of Superintendents (Category-3, some of the Senior Superintendents are deputed to the other courts on Administrative convenience, for smooth functioning of the Courts in the District, the undersigned is pleased to pass the following:-

ORDER:

1. Sri K. Rajakumar, Superintendent (Category-3), Civil Judge's (Junior Division) Court, Banaganapalli, is selected and temporarily promoted to the post of Senior Superintendent (Category-2 of APJMSS Rules-2019) and he is transferred and posted to act as **Senior Superintendent (Category-2)**, Principal District Court, Kurnool in the existing vacancy.

2. Sri C.Rajasekhar, Superintendent (Category-3), Civil Judge's (Junior Division) Court, Nandikotkur, is selected and temporarily promoted to the post of Senior Superintendent (Category-2 of APJMSS Rules-2019) and he is transferred and posted to act as **Senior Superintendent (Category-2), in the Civil Judge's Court, (Senior Division) Atmakur, in the existing vacancy.**

After joining duty, in the Court of Civil Judge's Court (Senior Division), Atmakur, the said individual is directed to work on deputation in the Civil Judge's (Junior Division) Nandikotkur, until filling up the post of Superintendent, in the court of Civil Judge (Junior Division) Nandikotkur.

3. Sri Kuruva Naga Raju, Superintendent (Category-3), Civil Judge's Court (Junior Division), Yemmiganur, is selected and temporarily promoted to the post of Senior Superintendent (Category-2 of APJMSS Rules-2019) and he is transferred and posted to act as **Senior Superintendent (Category-2) in the Special Court for Trial of POCSO Act, Kurnool,** in the existing vacancy.

After joining duty in the Special Court for POCSO Act, Kurnool, the said individual is directed to work on deputation in the Special Mobile Court for Trial of Cases under PCR Act -cum-III Additional Civil Judge Court (Junior Division) Kurnool, until filling up the post of Superintendent, in the above said court.

4. Smt B. Sanjeeva Kumari, Superintendent (Category-3), Principal District Court, Kurnool, is selected and temporarily promoted to the post of Senior Superintendent (Category-2 of APJMSS Rules-2019) and she is transferred and posted to act as **Senior Superintendent (Category-2) in the Special Court for Trial of ACB & SPE Cases, Kurnool,** in the existing vacancy.

After joining duty, in the Special Court for Trial of ACB & SPE Cases, Kurnool, the said individual is directed to work on deputation in the Establishment of the Principal District Court, Kurnool until further orders.

5. Sri Kondajjula Naga Raju, Superintendent (Category-3), Civil Judge's (Senior Division) Court, Dhone, is selected and temporarily promoted to the post of Senior Superintendent (Category-2 of APJMSS Rules-2019) and he is transferred and posted to act as **Senior Superintendent (Category-2) in the Special Court for Trial of CBI Cases, Kurnool**, in the existing vacancy.

6. The deputation of Sri M. Rajasekhar Babu, Senior Superintendent, Principal Civil Judge's (Senior Division) Court, Kurnool, to work in Principal District Court, Kurnool is hereby cancelled and further he is hereby transferred and posted to act as Senior Superintendent/Central Nazar, Principal District Court, Kurnool, in the existing vacancy.

The post of Senior Superintendent, Principal Civil Judge's (Senior Division) Court, Kurnool, is kept vacant for the present.

NOTE:

1	The promotes are hereby informed that their promotions are made purely on temporary basis and they will be reverted at any time without prior notice for unsatisfactory performance or on administrative grounds, without assigning any reason.
2	The individuals shall hand over complete and detailed charge of their respective posts to the persons placed in-charge on or before <u>10/9/24</u> and compliance shall be reported to this court with due certification by the Presiding Officer concerned, if any deviation will be considered as a misconduct. Further, the individuals shall take over complete charge of their new posts on or before <u>15/9/24</u> if any deviation, they will be considered as misconduct. Any correspondence regarding non-taking of detailed charge by any employee will not be entertained, at alter point of time.
3	It is hereby informed to the individuals that their seniority in the promotion post will be the same as in the proceedings, but not the date of joining in their promotion posts.
4	The above individuals shall deposit an amount of Rs.50,000/- towards Security Deposit in the shape of FDR/NSC as per Rules 22 of APJMS Rules-2019, failing which, his/her promotion shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge him/her from the service of revert him/her to the post from which he/she was promoted, as tye case may be, unless, he/she has already been otherwise discharged or reverted.

5	Any request for change of postings will not be entertained and such effort will be viewed seriously.
6	The officers concerned are requested to relieve the individuals, invariably without any request and they are required to submit the date of relief and joining of the individuals concerned to this office.
7	This orders is placed in the official website of District Court, Kurnool i.e., http://districts.courts.gov.in/Kurnool and the downloaded copy from the website is valid for relieving and joining duty.
