2	The promotee is hereby informed that his promotion is made purely on temporary basis and do not confer any right of probation or re-promotion and he will be reverted at any time without prior notice for unsatisfactory performance or on administrative grounds, without assigning any reason.
3	The individual shall hand over complete and detailed charge of his post to the person placed in-charge and compliance shall be reported to this court with due certification by the Presiding
4	Any request for change of posting will not be entertained and such effort will be viewed seriously.
5	The individual shall deposit an amount of Rs.10,000/- towards Security Deposit in the shape of FDR/NSC as per Rules 22 of APJMSS Rules-2019, failing which, his promotion shall deposit to have been terminated and the appointing authority shall forthwith, by order, promoted, as the case may be, unless, he/she has already been otherwise discharged or reverted.
6	The officers concerned are requested to relieve the individuals, invariably without any request and they are required to submit the date of relief and joining of the individuals concerned to this office.
