In pursuance of the references above to fill up vacancies in the cadre of Stenographer Grade-II on promotions (Category-5) from the cadre of Stenographer Grade-III (Category-6) Service Registers, Confidential reports and Special Reports are called for from the eligible candidates in the reference 5th cited and after perusing the confidential files and special reports of the individuals, interviews were held on 10-09-2024 and certain candidates are selected temporarily and promoted to the post of the Stenographer Grade-II (Category-5) of APJMSS Rules-2019 and due to shortage of stenographers, the Stenographers are deputed to the same courts on Administrative convenience and for smooth functioning of the Courts in the District,.

Further, Sri S. Shantha Kumar, who was voluntarily retired from service as Stenographer Grade-I (Category-4) was reinstated into service with all consequential benefits. Stenographer Grade-1 is filled subject to instructions of the Hon'ble High Court of A.P. on conditional basis as last come first go basis and on undertaking to that effect.

Upon considering the submitted circumstances, the undersigned is pleased to pass the following:-

ORDER:

- 1. Sri K.V.R. Narasinga Rao, Stenographer Grade-III, Principal Civil Judge's Court (Junior Division) Nandyal, is temporarily selected and promoted to the post of Stenographer Grade-II (Category-5 of APJMSS Rules,2019) and he is transferred and posted to act as Stenographer Grade-II (Category-5) in the II Additional Civil Court, (Senior Division) Nandyal in the existing vacancy. After his joining duty in the Court of II Additional Civil Judge's Court (Senior Division) Nandyal, he is directed to work on deputation in Principal Civil Judge's Court (Junior Division) Nandyal until further orders.
- 2. Sri V. Raghavendra, Stenographer Grade-III, I Additional Civil Judge's Court (Junior Division) Kurnool is temporarily selected and promoted to the post of Stenographer Grade-II (Category 5 of APJMSS Rules,2019) and he is transferred and posted to act as Stenographer Grade-II (Category-5), Principal Civil Judge's Court, (Senior Division) Kurnool in the existing vacancy. After his joining duty in the court of Principal Civil Judge's Court (Senior Division) Kurnool, he is directed to work on deputation in I Additional Civil Judge's Court (Junior Division) Kurnool, until further orders.

NOTE:

The promotion of SI.No.2 employee to the post of Stenographer Grade-II (Category - 5) is subject to instructions of the Hon'ble High Court of A.P. regarding Sri S.Shantha Kumar, Stenographer Grade-I and the individual is directed to execute an undertaking affidavit that he will step down on the basis of last come first go basis.
The promotees are hereby informed that their promotion is made purely on temporary basis and do not confer any right of probation or re-promotion and they will be reverted at any time without prior notice for unsatisfactory performance or on administrative grounds, without assigning any reason.
The individuals shall hand over complete and detailed charge of their respective posts to the persons placed in-charge and compliance shall be reported to this court with due certification by the Presiding Officer concerned, any deviation, he will be considered as a misconduct. Further, the individual shall take over complete charge of his new post immediately. Any correspondence regarding non-taking of detailed charge by any employee will not be entertained, at later point of time.
It is hereby informed to the individual that his seniority in the promotion post will be fixed as per the orders of seniority shown and also from the date of this proceedings, but not the date of joining in his promotion post.

5	Any request for change of posting will not be entertained and such effort will be viewed seriously.
6	The above individuals shall deposit an amount of Rs.10,000/- towards Security Deposit in the shape of FDR/NSC as per Rules 22 of APJMS Rules-2019, failing which, his/her promotion shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge him/her from the service of revert him/her to the post from which he/she was promoted, as tye case may be, unless, he/she has already been otherwise discharged or reverted.
