Interviews held on 23-09-2024 and the following Senior Assistants (Category-4) are selected temporarily and promoted to the posts of the Superintendents (Category-3) of APJMSS Rules-2019), the undersigned is pleased to pass the following:-

## ORDER:

1. The deputation of Ms. S. Fathima Bi, Senior Assistant (Category-4), Special Court for Trial of Cases against Women-cum-VII Additional District Judge's Court, Kurnool to work in POCSO Court, Kurnool is hereby cancelled.

Further, Ms. S. 3	The above individuals i.e.,SI No.1 & 2 shall deposit an amount of Rs.25,000/- towards Security Deposit in the shape of FDR/NSC as per Rules 22 of APJMS Rules-2019, failing which, his/her promotion shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge him/her from the service of revert him/her to the post from which he/she was promoted, as type case may be, unless, he/she has already been otherwise discharged as reverted.
