The High Court in it's Order dated 01.02.2024 passed in Civil Revision Petition No. 5435 of 2018 observed that the majority of communication in the society is through whatsapp, e-mail, SMS etc., and hence, the Courts cannot be shut out from these technological advances and practices of the society. To enable service of notice through these modes of service, the registered address furnished by the parites to the lis should be inclusive of e-mail address (if available) and registered mobile number of the parties which is linked to their respective Aadhar Card or Bank account. These modes of service help in quick service and help in seamless process of adjudication. It has been noted that these modes of service have to be treated as additional modes of service only but not as substitute to statutory mode of service.

Therefore, in continuation of the High Court's circular issued in the reference cited, all the Advocates and Party-in-persons are hereby instructed to provide mobile numbers and e-mail addresses of the parties to the litigation, at the time of filing the cases in the High Court and District Judiciary, for effecting service through whatsapp, e-mail,

SMS, as additional mode of service only.
