## CIRCULAR No. 11/2024

High Court of Andhra Pradesh – Disposal of cases within the timeframe stipulated by the High Court – Certain instructions – Reg.

It has been brought to the notice of the High Court that requests for extension of time for disposal of main cases or Interlocutory Applications are being made by the Presiding Officers of the Courts in District Judiciary including Tribunals, with enormous delay, after the expiry of the time initially fixed for disposal of the cases by the High Court. The High Court has time and again expressed deep concern over the delay in adhering the directions, where timeframe is stipulated, holding that the Presiding Officers of the Courts in District Judiciary including Tribunals and authorities on administrative side should ensure compliance with the directions/orders passed by the High Court for disposal of the cases and the indolence to comply the directions in disposal of the cases could not be countenanced.

Officers of the Courts in the District Judiciary including the Tribunals working under the control of the High Court and the authorities on administrative side as well, to ensure compliance within the timeframe stipulated by the High Court and in the event of any hindrance to adhere compliance of timeframe, proactive efforts should be made by addressing a

letter to the High Court seeking extension of time before the expire of the deadline.

Therefore, all the Presiding Officers of the Courts in the District Judiciary including the Tribunals working under the control of the High Court as well as the authorities on administrative side shall make every endeavour to dispose of the cases as directed by the High Court. In the event of any inability to dispose of the cases within the stipulated timeframe, shall henceforth address letter seeking extension of time well in advance, at least one week before expiry of the stipulated timeframe.

All the unit heads are requested to acknowledge the receipt of the circular and communicate the same to all Judicial Officers working within their respective units.

Any deviation of compliance with the above circular instructions will be viewed seriously.
