3	The promotes are hereby informed that their promotions are made purely or temporary basis and they will be reverted at any time without prior notice for unsatisfactory performance or on administrative grounds, without assigning any reason.
4	It is hereby informed to the individuals that their seniority in the promotion post will be the same as in the proceedings, but not the date of joining in their promotion posts.
5	The above individuals shall deposit an amount of Rs.10,000/- towards Security Deposit in the shape of FDR/NSC as per Rules 22 of APJMS Rules-2019, failing which, his/her promotion shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge him/her from the service of revert him/her to the post from which he/she was promoted, as type case may be, unless, he/she has already been otherwise discharged or reverted.
6	Any request for change of postings will not be entertained and such effort will be viewed seriously.
7	The officers concerned are requested to relieve the individuals, invariably without any request and they are required to submit the date of relief and joining of the individuals concerned to this office.
