**SUB: VIDEO CONFERENCE** - Compliance with the instructions issued by Hon'ble Sri Justice Ravi Cheemalapati garu, Judge, Hon'ble High Court of Andhra Pradesh at Amaravati during the Video Conference held with all the Judicial Officers of Kurnool District on 02-01-2025 - Regarding.

During the course of Video Conference held with all the Judicial Officers of Kurnool District on 02-01-2025 with regard to the infrastructure facilities, including wash room facilities available in each Court in Kurnool District, Hon'ble Sri Justice Ravi Cheemalapati garu, Judge, Hon'ble High Court of Andhra Pradesh at Amaravati has issued certain specific instructions to each and every Judicial Officer of this District. Adherence to those instructions issued by Hon'ble Sri Justice Ravi Cheemalapati garu, Judge, Hon'ble High Court of Andhra Pradesh at Amaravati during the said Video Conference is very essential for the efficient functioning of the Courts in the District. To ensure that all directions issued by Hon'ble Sri Justice Ravi Cheemalapati garu, Judge, Hon'ble High Court of Andhra Pradesh at Amaravati are promptly and effectively implemented, all the Judicial Officers of Kurnool District are required to follow these guidelines:

1. **Prompt Action:**

Implement the instructions issued by the Hon'ble Judge, High Court of A.P. during the said Video Conference, without delay.

2. **Detailed report:**

Submit a detailed report of all the instructions issued by the Hon'ble Judge, High Court of A.P. during the said Video Conference along with the estimates for the repair works/new works for providing wash room facilities, where-ever required in the Courts and the actions taken in response to those instructions, to the District Court, Kurnool forthwith, for submitting the same to the Hon'ble High Court of Andhra Pradesh at Amaravati.

3. **Verification:**

Ensure that the instructions issued issued by the Hon'ble Judge, High Court of A.P. during the Video Conference are accurately understood and communicated to the relevant personnel.

4. **Follow-Up:**

Provide timely updates to the District Court, Kurnool on the implementation status of the instructions issued by the Hon'ble Judge, High Court of A.P. during the said Video Conference.

Therefore, all Judicial Officers in Kurnool District are hereby directed to follow the above guidelines scrupulously and submit reports along with the estimates for the repair works / new works for providing wash room facilities, where-ever required in the Courts, to the District Court, Kurnool **forthwith**, for submitting the same to the Hon'ble High Court of Andhra Pradesh at Amaravati.
