Results were published through online in the reference 3rd above by the Hon'ble High Court of A.P. In the ref.4th above, candidates who provisionally selected were instructed to produce their Original certificates and other documents before the Learned Principal District Judge, Kurnool for due verification by the entrusted staff members from 19.01.2026 to 23.01.2026. Accordingly, some of the selected candidates were appeared before this Unit for verification.

In pursuance of the instructions issued by the Hon'ble High Court of A.P. in the reference 4th above, on perusal of Original certificates and other documents of the selected candidates who have appeared in this Unit , the undersigned is pleased to issue appointment Orders appointing the following individual as **FIELD ASSISTANT** under Direct Recruitment purely on temporary basis subject to verification of the antecedents. Conditions are also mentioned.

1. These Orders shall come into force with immediate effect.
2. The appointee is informed that his appointment is purely temporary subject to verification of his/her antecedents and it does not confer any right of probation or reappointment and that he will be ousted from service at any time without notice and without assigning any reason.
3. The appointee is informed that the documents produced by him/her are found to have been created, manipulated, interpolated or forged in future date they will be removed / dismissed from the service besides launching criminal prosecution against them.
4. **The appointee is directed to join duty on or before 31.01.2026**
5. The appointee is directed to produce physical fitness certificate issued by the Medical Officer not below the rank of Civil Surgeon at the time of joining duty.
6. The Presiding officers of the respective Courts are requested submit
 - a. Joining report
 - b. Physical Fitness Certificate
 - c. Agreement Bond as per Rule 21(b) of A.P.J.M.S.S. Rules, 2019
7. The Officer concerned is requested to direct the appointee to execute an agreement bond that he shall serve the Department for a period of two years the completion of training as per Rule 21(b) of Andhra Pradesh Judicial Ministerial Subordinate Service Rules, 2019 and submit the same to the District Court, Kurnool.
8. If the appointee fails to serve the Department for a period of two years, for any reasons, or if he discontinues the training or is discharged from training course for misconduct or any other reasons, or if he secures any other employment elsewhere than under the State Government, he shall be liable to refund to the Government the pay and allowances or any other remuneration received by him in addition to the amount spent by the Government in his training as per Rule 21 C (i)(ii)(iii) of Andhra Pradesh Judicial Ministerial Services Rules, 2019.
9. The individual is hereby informed that he will be covered by the contributory pension scheme and A.P. Revised Pension Rules, 1980
10. The individual is informed that he should abide to the rules incorporated in G.O.Ms.No.76 LAW (L,LA & J Home Courts .A) Department dt. 15.05.2019 of the A.P. Judicial Ministerial Subordinate Service Rules .

11. The individual shall obtain a "self" fixed deposit receipt of Rs.10,000/- towards security for the due and faithful performance of his duties attached to within a month from the date of his appointment as per Rule 22 of G.O.Ms.No.76 LAW (L,LA & J Home Courts .A) Department dt. 15.05.2019 of the A.P. Judicial Ministerial Subordinate Service Rules .
12. The individual is informed that this proceedings does not confer permanent appointment and at any time his services are liable to be terminated without any notice in violation of above conditions.
13. The individuals are directed to produce one set of Photostat copies of educational qualification certificates at the time of joining duty before the Presiding Officer of the respective Courts, where the individual is posted.
14. The candidates in the above proceedings who are now working in Other Departments are directed to submit Resignation certificate from their employer and submit the same in District Court, Kurnool before joining.
15. The candidates are further informed that appointment proceedings are issued basing upon merit and seniority fixed on merit.
16. The individuals are not entitled to any deputation allowance.
