TERMS AND CONDITIONS:-

Cover-I:

- 1. Copy of the firm registration certificate with validity date for supply of furniture articles, copies of the tax registration certificate and previous tax paid receipts for last two years.
- 2. An EMD of Rs. 12500/- by way of a DD in favour of the Prl. District & Sessions Judge cum Tender Bulletin Officer, Udupi. The bid cover No. I not containing such DD will be rejected and the same will not be considered.

Cover-II (Financial Bid/ Rate list)

- 1. The rate quoted price shall be inclusive of all incidental charges up to the stage of supply to the location and taxes applicable.
- 2. The Tenderers shall quote the rate for each item of furniture articles only as mentioned in the specification.
- 3. The validity of the rates quoted shall be for one year. For any reasons or under any other circumstances, the rates quoted will not changed.

4. If suppliers or Bidders fail to supply the furniture items as per the supply order, the Security deposit/EMD of Rs. 12500/-will be forfeited to the Government. The firm name and the account will be included in the black list of this office.

General Conditions:

- 1. The supply of the articles should be strictly in conformity with the specification mentioned in the annexure.
- 2. The workmanship should be good. There should be no defect in the articles. It shall be strictly noted that, it will be the responsibility of Successful Tenderer to supply the materials at the destination in good conditions, within specified time.

- 3. The Successful Tenderer has to supply the furniture items within 14 days from the date of supply order in good condition and as per specification. The Successful Tenderer has to execute a Bond undertaking to supply the items within the prescribed period in good condition as per specification and to carry out the obligations during the warranty period. Breach of conditions of the bond will make the Successful Tenderer liable to pay the damages/penalty that may be determined and imposed by the undersigned.
- 4. The Tenderer shall furnish an unconditional warranty for a period of 2 years.
- 5. The Supplier should deliver the furniture at his own cost to the destination.
- 6. A separate certificate should be produced regarding the quality from Department of Industries and Commerce and Karnataka Forest Department, Government of Karnataka, before delivery of furniture items.
- 7. The successful Tenderer is liable for payment of liquidated damages and penalty in the event of non-fulfillment of any of the terms or whole of the contract.
- 8. Payment will be made on satisfactory supply of the furniture articles within the due date and on submitting bills in duplicate to the Tender Inviting Authority.
- 9. The quantity of the articles will be altered if found necessary.
- 10. The tenderer shall produce the E.M.D. Amount by way of D.D. in favour of the Prl. District and Sessions Judge, Udupi.
- 11. The full payment of the materials will be made from this office only after inspection and acceptance of the materials and stock certificate received from the concerned court.
- 12. This office does not bind itself to accept the lowest tender or any tender and reserves itself the right of accepting the whole or any part of the tender or portion of the quantity offered and the Tenderer shall supply the same at the rate quoted, fail which, the entire tender process may be cancelled by the undersigned without assigning any reasons.
