I.EDUCATIONAL QUALIFICATIONS:

The applicant must possess Graduation from a recognized University in India and has passed the Government Technical Examination in Typewriting by Higher Grade in English and if such persons are not available, passing Government Technical Examination in Typewriting by Lower Grade in English will be considered, as per Rule 6 (2) (g) A.P. State Legal Service Authority Service Rules, 1999. The applicants who possess technical qualifications like Computers, Shorthand etc., will be given preference.

II.AGE LIMIT:

The applicant must have completed 18 years and must not have completed 42 years as on 01-09-2023 as per G.O. Ms.No.101, General Administration (SER.A) Dept., 30-09-2022 r/w. A.P. State Legal Services Authority Service Rules, 1999.

Provided that the upper age limit of 42 years is relaxable by 5 years in respect of the persons under Scheduled Castes/Scheduled Tribes/Backward Classes and EWS.

Provided that the upper age limit of 42 years is relaxable by 10 years in respect of physically disabled persons. (Contd..2..)

Provided that the upper age limit of 42 years is relaxable for Ex-Servicemen as per A.P. State and Subordinate Service Rules, 1996 r/w. A.P. Last Grade Service Rules, 1992.

III.METHOD OF RECRUITMENT:

- A written test and or Interview will be conducted to the candidates depending upon the number of applications received and as per the directions of the Chairman, District Legal Services Authority, Vizianagaram.
- 2. The decision of the Chairman, District Legal Services Authority, Vizianagaram shall be final with regard to the said recruitment process.
- 3. Preference will be given to the candidates who possess higher studies and technical skills like computers etc.,
- 4. No person shall be eligible for appointment unless he/she satisfies the following conditions:
 - That he/she is of sound health, active habits and free from any bodily defects or infirmities rendering him/her unfit for the appointment.
 - ii) That his/her character is such as to quality him/her for such service.
 - iii) He/she must be citizen of India.

VI.GENERAL INSTRUCTIONS:

- 1. The applicants shall indicate their local/non local status in the application.
- 2. Merely applying for a post will not give any right to any person to be considered for appointment.

- 6. No person, who has been convicted by a Court of Law for an offence involving moral turpitude, shall be eligible for appointment.
- 7. No TA and DA will be paid to the candidates who appear for written test/ Interview.
- 8. Candidates resorting to or bringing any influence of any kind will be summarily disqualified and they are liable for prosecution as per Law.
- 9. The particulars furnished by the applicant in the application form will be taken as final. Candidates should, therefore, be very careful in filling the application.

- 11. If suppression of information/furnishing of false information is noticed, either in the application or in the enclosures, at any stage before the final selection, the application of the candidate will summarily be rejected. In addition, the candidate will also be liable for appropriate action/prosecution as per Law.
- 12. No information will be sent to the unsuccessful candidates after announcement of list of qualifying candidates in the Written test/Interview.
- 13. The applications with incomplete data, without photographs, without required enclosures, without self addressed cover with postal stamps, without signature in the application form will summarily be rejected.
- 14. The applications received after due date will summarily be rejected.
