

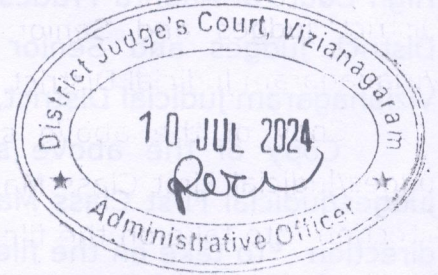
Therefore, you are requested to take necessary action in the matter.
