

On the occasion of the World Environment Day, this year, i.e. June 5, 2024, Hon'ble Prime Minister Shri Narendra Modi launched a Global Campaign #एक\_पेड़\_मां\_के\_नाम #Plant4Mother. The Hon'ble Prime Minister exhorted people to plant trees as a mark of love and respect for one's own Mother, and for protecting and preserving Mother Earth.

- As part of the #एक\_पेड़\_मां\_के\_नाम# Plant4Mother campaign, efforts are 2. being made to ensure that about 80 crore saplings are planted across the country by September, 2024 and about 140 crore saplings by March, 2025. The Campaign has immense potential for preventing and reversing land degradation and desertification.
- I am happy to convey that since its launch, the campaign has gathered momentum and details regarding plantation of more than 15 crore saplings have already been uploaded on the Ministry's portal. In the Ministry of Environment, Forest and Climate Change, we undertook a tree plantation activity at Asola Bhati Wild Life Sanctuary on June 20, 2024 wherein each individual planted a tree in honour of their mother.
