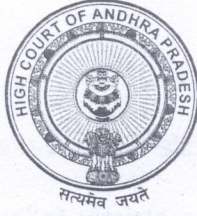

Sub: High Court of Andhra Pradesh – A.P. Advocates Welfare Fund Act, 1987 – To affix "Nyayavadula Mariyu Vari Gumasthala Samkshema Nidhi" stamp of Rs.250/- on every Vakalat/Memo of Appearance – Circular Instructions issued – certain deviations noticed – Instructions issued – Reg.

Adverting to the subject and reference cited, I am to inform that High Court has issued circular instructions in reference 2nd cited, directing all the Presiding Officers of the District Judiciary in Andhra Pradesh to ensure that every Vakalat/Memo of appearance filed before the Courts and Authorities bears "**Nyayavadula Mariyu Vari Gumasthala Samkshema Nidhi**" stamp worth Rs.250/- (Rupees two hundred and fifty only) from 1st April, 2024 in consonance with the amended provisions of Section 12 & 12(A) of the A.P. Advocate Welfare Fund Act.

In this regard, the Secretary, Bar Council of Andhra Pradesh vide letter reference 1st cited, has informed that during the verification of Bank Statement of the A.P. Advocates Welfare Fund" it was noticed that advocates in Kadapa District i.e., Kadapa, Pulivendula, Rayachoty, Jammalamadugu, Lakkireddipalli are depositing the amount of Rs. 250/- towards welfare Fund Stamp directly in the State Bank of India and attaching

the deposit slips to the Vakalats while filing Vakalats in the Courts and requested to issue instructions to the concerned to strictly follow the circular instructions issued vide 2nd reference.

Therefore, I request you to instruct the concerned to accept only "Nyayavadula Mariyu Vari Gumasthala Samkshema Nidhi" stamp on Vakalaths/Memos of appearance and not to accept deposit of Rs.250.

Further, all the Unit Heads are requested to circulate the aforesaid instructions to all the Judicial Officers working in their respective units.
