- Note:-**(1) The **Serial No.1 to 7** are informed that their appointments are made purely on temporary basis and their services are liable to be terminated at any time without prior notice and without assigning any reasons and does not give them any preferential claim for future appointment.
- (2) All the individuals shall **join duty on or before 07.02.2026** failing which, their names will be removed from the selection list, and no correspondence, in this regard, will be entertained.
 - (3) They will be covered by the Contributory Pension Scheme and that the Pension Scheme as per A.P. Revised Pension Rules, 1980 will not be applicable to them.
 - (4) The seniority of the individuals will be fixed as per their merit, in view of the decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others [(2003) 5 SCC 604]. Seniority of the candidates will not be reckoned from the date of their joining duty.
 - (5) The individuals are informed, their appointment is made purely on temporary basis, **subject to verification of their antecedents**, and genuineness of their certificates, submitted, and if their antecedents are found not satisfactory and their certificates are found not genuine, their services will be terminated, at any time, without assigning any reasons, and they will be prosecuted, for submission of incorrect information, and certificates.
 - (6) They should produce Medical Fitness Certificate obtained from a Medical Practitioner not below the rank of Civil Surgeon/Assistant Civil Surgeon of Govt. Hospital at the time of joining before the Presiding Officers concern.

- (7) The individuals are directed to submit their antecedents forms filled in triplicate, in the prescribed proforma, enclosed herewith, along with self attested copies of their education qualifications, community, and study certificates, at the time of joining the post, without fail.
- (8) Selection of candidate against B.C.-E vacancy will, however, be subject to the outcome of Civil Appeal Nos. 2628 - 2637 of 2010 pending consideration before the Honourable Supreme Court of India.
- (9) Selection of candidate against E.W.S. vacancy will, however, be subject to the outcome of W.P.(Civil) No. 343 of 2019 and other cases, pending on the file of the Honourable Supreme Court of India.
