- i. Applications in prescribed format are invited from eligible candidates for engagement of persons on daily wages/ purely temporary basis to meet the required services of Group-D employees till completion of entire recruitment process and appointment of Group-D staff in the District & Sub-Ordinate Courts of this Judgeship under the Odisha District & Sub-ordinate Courts Group-D Employees (Method of Recruitment and Conditions of Service) Rules, 2021.
- ii. **No. of vacancies – 50 (Fifty)**
- iii. **The Last Date & Time for receipt of Application : 01.11.2024**
- iv. **Terms and Conditions of Engagement.**
  - a) The engagement of persons on daily wages/purely temporary basis on payment of minimum wages of unskilled labour which shall be enhanced from time to time as would be fixed by the Govt. of Odisha. He/She will be liable to be disengaged at any time without notice.
- v. **Eligibility :**
  - a) Must have passed M.E. standard (Class-VII) examination conducted by any School or Educational Institution.
  - b) Must be over 18 years.
  - c) Must be good character.
  - d) Must be of sound health, good physique and free from organic defects or bodily infirmity.
  - e) Must be able to speak & read in Odia language.
- vi. **Pay and other allowances :**

On payment of minimum daily wages of unskilled labour i.e. Rs.450/- which shall be enhanced from time to time as would be fixed by the Govt. of Odisha.
- vii. **Extra knowledge :- if any**

Such as :- Driving, Electrical, Plumbing, Cooking, Gardening etc.
- viii. **Date , Time and Place of Walk in Interview :**

The date, time and place of Walk-in-interview will be notified and intimated after scrutiny of the applications.


