OFFICE ORDER

As per the guidelines of Punjab State Legal Services Authority, SAS Nagar, Para Legal Volunteers can be recruited for making the general public aware about free legal services and various NALSA and Central/State Government Schemes. As per the requirement of the District Headquarter, DLSA, Patiala, 30 PLVs are to be recruited and for this purpose, advertisement was given in Jagbani newspaper and the last date of filing applications was 29.01.2024. Total 104 applications have been received.

As per scheme for PLVs (revised) at page no. 35 of Compendium II Punjab Legal Services Authority, SAS Nagar, the PLVs are to be selected by the Committee Chaired by undersigned as Chairperson of District Legal Services Authority, Patiala, Secretary of District Legal Services Authority, Patiala as member and Sh. H. S. Grewal, Addl. District & Sessions Judge-1, Patiala has been nominated as 3rd member of the Committee.

Interview of candidates was conducted by the Committee on 01.02.2024. 104 applications were received. Out of these, 71 applicants appeared in the interview. Remaining 33 applicants were absent. After conducting the interview, the committee finds 30 candidates as suitable for appointment in Head Quarter Patiala, which are as follows:-
