- 3. The duty work will be performed by the Judicial Officers as per the duty roster prepared by the Chief Judicial Magistrate, Patiala.
- 4. During the period from 1<sup>st</sup> June, 2024 to 15<sup>th</sup> June, 2024, the urgent civil matters shall be attended by Sh.Atul Kamboj, Civil Judge (Sr.Divn.), Patiala, and in case he proceeds on leave, those cases shall be attended by the next Duty Officer in order of seniority

- 6. However, after the summer vacations, all the freshly instituted **civil matters at Sub-Divisions,** Nabha, Samana and Rajpura, during the period from **16**<sup>th</sup> **June, 2024 to 30**<sup>th</sup> **June, 2024**, shall be put up before the concerned Additional Civil Judges (Sr.Div.), for entrustment.
