In pursuance of this office notification No. ADM.DJS.13230/2022, dated: 29.06.2022, for selection of 4 posts of Stenographer in the unit of District and Sessions Judge, Shivamogga, the candidates as mentioned at Annexure are eligible to appear for qualifying test which is scheduled to be held on **06.08.2023 at 08.30 a.m at H.S. Rudrappa National Pre University College, Savalanga Road, Near Kuvempu Rangamandir, Shivamogga.**

Further, the candidates eligible for qualifying test are required to produce below mentioned documents along with one set of self attested copies during the time of qualifying test for verification without fail.

1. S.S.L.C or Equivalent Marks Card for proof of Date of Birth and Identity Card (Adhar Card/Voter ID/Driving License) for address proof.
2. II PUC/Diploma/Equivalent Marks Card.
3. Kannada Shorthand Senior Grade Marks Card/Equivalent Marks Card.
4. English Shorthand Senior Grade Marks Card/Equivalent Marks Card.
5. Kannada Typewriting Senior Grade Marks Card/Equivalent Marks Card.
6. English Typewriting Senior Grade Marks Card/Equivalent Marks Card.
7. If claiming reservation under SC/ST/Cat-IIA/Rural from I Std. to X Std and creamy Layer certificates obtained from the competent authorities within the stipulated period.


8. Documents for age relaxation, if any.
9. The candidates shall produce the original conduct certificate issued by the last educational institution attended by him/her. He/she shall also produce two original Character Certificates given not more than six months prior to this date by the respectable persons unconcerned with his/her educational institution and not related to him/her, testifying to his/her character.
10. Two passport size photos.

The candidates, who fail to produce the original certificates/documents on the date of qualifying test, will not be allowed to appear for qualifying test.

**Individual admission ticket will be uploaded on the District Court Web Site and the candidates are required to download the same and produce while appearing for the Qualifying Test.**

**Note: Mode of qualifying test is as follows:**

1. A English passage containing 600 letters will be dictated in 5 minutes and the candidates have to take the same on the Shorthand and transcribe the same on the computer within 45 minutes.
2. A Kannada passage containing 1300 letters will be dictated in 5 minutes and the candidates have to take the same on the Shorthand and transcribe the same on the computer within 45 minutes.
3. Kannada transcription will be conducted on Computers and the Key board layout is as same as Kannada Typewriter machine. Practice link will be published in District Court website, in due course.


