- 2 II PUC/ Diploma / Equivalent Marks Card.
- 3 English Shorthand Senior Grade Marks Card//Equivalent Marks Card.
- 4 Kannada Shorthand Senior Grade Marks Card//Equivalent Marks Card.
- 5 English Typewriting Senior Grade Marks Card/Equivalent Marks Card.
- 6 Kannada Typewriting Senior Grade Marks Card/Equivalent Marks Card.
- 7 If claiming reservation under SC/Cat-I/II B/ Rural from I Std. to X Std and Creamy Layer etc., certificates obtained from the competent authorities within the stipulated period.
- 8 Documents for age relaxation, if any.
- 9 The candidate shall produce the original conduct certificate issued by the last educational institution attended by him/her. He/she shall also produce two original Character Certificates given not more than six months prior to this date by the respectable persons unconcerned with his /her educational institution and not related to him/her, testifying to his/her character.

If the candidates fail to produce the Original documents at the time of Viva-Voce, their candidature will not be considered for selection.
