PREAMBLE: The Hon'ble High Court of Karnataka, Bengaluru, vide letter cited at reference 1 above distributed the posts of Senior Sheristedar / Bench Clerk Grade-I to this unit as per Annexure cited at reference 2 above and had directed to take suitable action to cause promotion as contemplated in Rule 4(4) of the Karnataka State Civil Services (Regulation of Promotion, Pay and Pension) Act, 1973 and Rule 7 of the

Karnataka State Civil Services (Classification, Control and Appeal) Rules, 1957. It is also informed that, necessary action may be taken, pending approval of the Government for considering the District Judges as the Appointing Authority for the Group-B posts as per Rule 7 of the Karnataka State Civil Services (Classification, Control and Appeal) Rules, 1957.
