5. The Officials who are transferred shall make all preparations for handing over the charge during the Summer Vacation and during their Joining Time.
6. No Officials shall avail Earned Leave for the purpose of handing over the charge.
7. The Presiding Officers who are having Administrative Charge shall prepare work distribution amongst the Officers/Officials immediately, under intimation to this office.
8. Officials who have been transferred and are residing in Government /PWD Quarters must vacate the Quarters within one month of their transfer.
