The Additional District Judge-VIII/ Additional MACT, Ernakulam and Additional District Judge-I/Additional MACT, Pathanamthitta will take such additional charge and continue to hold the same, until further orders.

If any officer mentioned in Column No.IV happens to be absent on the date of his/her taking/handing over charge, the officer at Column No.II may take/hand over charge from/to the officer who has been placed in full additional charge of such officer.-
