Consequent upon the Advertisement dated 25.07.2023, the following candidates have been successfully qualified in the written examination held on 10.12.2023 for the post of Junior Clerk-cum-copyist, Junior Typist and Stenographer Grade-III in the judgeship of Sonapur.

The candidates qualified for the post of Junior Clerk-cum-Copyist shall appear in the Computer Science Test (Practical). The candidate qualified for the post of Stenographer Grade-III shall be examined in short hand and Type writing test and those candidates qualified for the post of Junior Typist shall be examined in Type writing test. The candidates selected in the aforesaid test as applicable to Stenographer Grade-III and Junior Typist shall be called for to appear Computer Science Test (Practical).

Further, the candidates who got qualified in the above tests as applicable for the post of Junior Clerk-cum-Copyist, Junior Typist and Stenographer Grade-III, shall be called for to appear in the Viva Voce Test subject to verification of their original testimonials, for which the candidates are instructed to bring all the original documents, the copy of which were submitted alongwith the application.

Note:-It is hereby informed that the said Computer Science Test (Practical) and the skill test, i.e. Stenography Test and Type writing Test are scheduled to be held on 18.02.2024 (Sunday) from 09.30 A.M. onwards in the District Court Complex, Sonapur followed by the Viva voce test on the same day for the candidates who qualify in the above skill test and computer science test(practical).

The candidates who have not received their respective admit cards on or before 15.02.2024, they may contact this office physically to obtain their duplicate admit cards on 16.02.2024 & 17.02.2024 from 10.30 A.M. to 05.00 P.M. on production of their one passport size photograph

and identity proof such as Voter card/Adhaar Card/PAN Card/Driving License.
