**Guidelines for Mode of SBI e-pay**  
Payment is to be done through State Bank India e-pay portal. Payment of modes are to be accepted like Net Banking (SB Account credentials only), Credit/Debit Cards of SBI and other Banks also and UPI ID /QRcode only.

**By SBI e-pay payment gateway**

- Netbanking, If you have account login credentials.
- Debit/Credit Cards
- UPI ID or UPI QRcode.
- Once Payment has done, Then verify the SBIe-pay payment Receipt.

Fill up the details such as Application Number and Date of Birth, which are fields displayed on page.

- Please do not leave any extra spaces before, in-between or After the Application No.
- Please note First three characters should be alphabets in capitals, i.e.,
- From 4th to 7th characters should be numerical, i.e., 2409
- From 8th to 10th characters should be alphabets in capitals, i.e.,
- Remaining from 11th to 16th characters should be numerical, i.e., 000001  
For Examples 2409000001 (Total 16 characters)

f. By Clicking on GO button Your entered details will be displayed, verify the details and click on Confirm button. Page will be directed to selection of payment mode - that is Netbanking, Credit/debit card or UPI ID, Screen. Select your payment mode and complete the payment and save receipt for your future reference.

**To UPI ID or QR CODE.**

If you are paying fee through UPI ID /QR CODE, click on UPI ID under the PAYMENT MODES button. Enter UPI id or if you are paying QRcode, scan it, click on confirm button to complete payment process.
