e-TENDER NOTIFICATION

Sealed Tenders are hereby invited from intending manufacturers/firms for the supply of steel furniture for the use of various Courts established in the various Talukas in Tumakuru District vide letter of permission No.DJBS 11/2004(Furniture) dated 03.07.2024 of the Hon'ble High Court of Karnataka, Bengaluru as per the specification mentioned against each article and on the terms and conditions mentioned here under.

1.	<p>STEEL ALMIRAH (6 ½ FT) with 18 G. for doors and 20 G. for body and Shelves. * OF SIZE 1.83 m H x 915 cm W x 48 cm D (including leg of 15.24 cm) fitted with four fixed shelves making five compartments double door with three way locking device and duplicate keys, all joints outside and inside should be spot or arc welded and neatly finished by grinding. The outside comers should be rounded off to give good appearance. The edges of doors and shelves should be properly bent U-shape of 25 mm width to ensure good strength on the edge of U-bent of the door lengthwise should be double folded and neatly finished. The shelves front side should be bent to U-shape neatly and finished to avoid any possible cuts to fingers and hand when handled. Longitudinal rib of 15.24 cm wide including bent to required shape should be provided and fixed to each door at its centre. The breadth of the shelf in the Almirah should be to the entire width leaving about 12-mm gap from the shutter when it is closed.</p> <p>LOCKING DEVICE: Three way locking device with 10 gauge M.S.Sheet for locking and lever plate, and with locking rod of 10 mm diameter with strong bracket at top and bottom to hold the locking rod with six lever lock should be provided. 65 mm size 6-lever strong lock to be fixed. Handle be made out of brass cost alloy to Godrej type. The almirah shall be derushted, primer coated and painted with Synthetic enamel paint, 18 gauge for doors and 20 for body and shelves.</p>	81
2	<p>STEEL RACK: Steel:Size:1.80 m x 0.90 m x 0.375m overall with fur upright and five panels, the uprights shall be slotted angle of section 40 x 40 x 2 mm and the panels of size 900 mm x 375 mm x 20 G. The panel should be fixed to the uprights by means of G1. Bolts of sized 8 mm x 16mm by providing 16nos. standard gussets at corners. The rack shall be painted as per indenter's choice.</p>	167

TERMS & CONDITIONS:

1. The sealed tender shall be submitted along with EMD of Rs.1,00,000/- by way of Account Payee D.D. drawn in the name of Prl.District & Sessions Judge, Tumakuru on any nationalized Bank payable at Tumakuru without which the tenders will not be considered.
2. Pursuant to ITT Clause 7, the Tenderer shall furnish as part of its Tender, documents establishing the Tenderer's eligibility to tender as its qualification to perform the contract if its tender is accepted.
3. All the articles should be supplied free of transportation at the destination.
4. The rates should be quoted inclusive of GST and other Taxes applicable.
5. The articles should be Steel with good quality and there should be no defect either in steel or in the manufacture. It should be strictly noted that it would be supplier's responsibility to supply the materials at destination in good condition.
6. Each article should bear the seal of the supplier for having inspected the same with reference to the specification mentioned against each article.
7. Each article shall bear the manufacture's trademark or other distinguished marks in addition to the particulars specified in the indent with certificate of manufacturer that the supplier is an authorized agent.
8. A separate certificate for having inspected the Steel furniture by the Department of Industry & Commerce, Govt. of Karnataka should be furnished at the time of delivery.
9. The supplier should replace all damaged or defective supplies if any, due to defective packaging, forwarding or handling to transit by the carrier, as the case may be within 15 days after receiving such report from this office.
10. This office will make full payment only after the acceptance and inspection of the Steel by the concerned Courts of this unit and also after the receipt of stock certificates from the concerned Courts.
11. The sizes and materials etc., used should be exactly in accordance with the specifications as noted above. The rights of acceptance of the Tender is reserved with the undersigned.
12. Articles should be contain the fixed period of warrant not less than TWO years towards manufacturing defects and the defective articles either to be replaced or rectified at the cost of supplier during the period of warranty.
13. Any failure on the part of the bidder to observe the prescribed procedure and many attempt to canvass for the work shall render the bidder's bids liable for rejection.

14. The Prl.District & Sessions Judge, Tumakuru reserves the right to award any or part or full contract to any successful bidder at their discretion and this will be binding on the bidder.
15. In case of failure to comply with the provisions of terms and conditions mentioned, by the successful bidder that has been awarded the contract, the Prl.District & Sessions Judge, Tumakuru has reserves the right to award the contract to the next lower bidder or any other outside agency and the difference of price shall be recovered from the defaulter agency who has been awarded the initial contract and this will be binding on the bidders.
16. **Time schedule:** The work shall be executed and completed as specified in the Supply Order from the date of award of the purchase order. The period of completion shall not be extended except for the reasons beyond the control of the successful bidder. The decision of the Competent authority of this office in this regard shall be final and binding.
17. **Liquidated damages:** The schedule of completion of the work shall be strictly adhered to as defined in the tender document, as time is the essence of the contract. Any unjustified and unacceptable delay in completion of the work shall render the contractor liable for liquidated damages a sum equivalent to 0.5% of the delivered price of the delayed goods for each week or part thereof of delay until actual delivery up to a maximum deduction of 10% of the contract price. Once the maximum is reached the Purchaser may consider termination of the contract pursuant to GCC clause 23.
18. The Tender should be submitted to this office on or before 05.00 p.m. of **09-08-2024** in a sealed cover mentioning “**Tender for supply of steel furniture**”. The tender documents can be downloaded from the Tumakuru Judiciary website <https://tumakuru.dcourts.gov.in/>.
