The following Notification shall be published in an Extraordinary issue of the Andhra Pradesh Gazette, dated:17.11.2020.

NOTIFICATION

In exercise of the powers conferred by sub section (1) of clause (17) of section 59 of the Prisons Act, 1894 (Central Act 9 of 1894), the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Prisons Rules, 1979 issued in G.O.Ms.No.386, Home (Prisons.B) Department, dated the 22nd May, 1979 published in Rules Supplement to Part-II of the Andhra Pradesh Gazette dated the 4th June, 1979 and as subsequently amended from time to time:-

AMENDMENT

In the said Rules, in Rule 10 for sub-rule (1), the following shall be substituted, namely:-

“(1) (a) Women prisoners sentenced to imprisonment exceeding one month including those sentenced to death by the courts in the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna and Guntur shall be committed to the Special Prison for Women, Rajamahendravaram.

(b) Women prisoners sentenced to imprisonment exceeding one month including those sentenced to death by the courts in the Districts of Prakasham, SPSR Nellore, Dr. YSR Kadapa, Kurnool, Anaparthi and Chittoor shall be committed to the Special Prison for Women, Kadapa.”
