**Sri C. Karthik Kumar Reddy**, (S/o. Late C. Vara Prasad Reddy, formerly Record Assistant, Junior Civil Judge's Court, Kamalapuram who died on 02.12.2020 while in Service), D.No. 7/3277 (Up), Srinivasa Nagar, Proddatur, Kadapa District is appointed as **Examiner** temporarily on **compassionate grounds** against R.P.No. 36 in Cycle-I (OC) and posted to act as Examiner, **Junior Civil Judge's Court, Kamalapuram** in the existing vacancy.

- 1) The candidate is informed that his appointment is purely temporary and liable to be terminated at any time without assigning any reason.
- 2) The above appointment will not confer any right to regular appointment.
- 3) The candidate shall furnish an "Undertaking" that he will discharge all legitimate duties that are entrusted to him as per the guidelines of the Hon'ble High Court of Andhra Pradesh.
- 4) Candidate shall produce all "Original Certificates" at the time of joining for verification.
- 5) The individual is directed to produce "Physical Fitness Certificate" in the prescribed proforma issued by a Medical Officer not below the rank of Civil Assistant Surgeon.
- 6) The Pay of the individual shall be drawn as per Rules in force.
- 7) The individual is directed to report for duty before the Junior Civil Judge, Kamalapuram **within 15 days** from the date of receipt of the proceedings, failing which the appointment Order automatically is liable to be cancelled. The Service shall count from the date of joining of duty by the individual.
- 8) The Probation of the individual commences from the date of joining for a period of two years in continuous period of three years as per existing Rules.
- 9) The individual is directed to give an "Undertaking" in writing that he will maintain properly the other family members, who were dependant on the deceased Government Servant and in case if it is proved subsequently at any time that the family members are being neglected or are not being maintained properly by him, he will be terminated from service.
- 10) The individual is also hereby informed that he will be covered by the Contributory Pension Scheme and the existing pension scheme as per the A.P. Revised Pension Rules, 1980 will not be applicable to him as per the instructions issued by the Government of Andhra Pradesh in G.O.Ms.No.655 Finance (Pension-I) Department dated 22.9.2004.



- 11) As per amended APJMSS Rules issued in G.O.Ms.No. 76, Law (L, LA & J-HOME - COURTS-D) Department, dt:15.05.2019, the individual has to deposit security to an amount of **Rs.10,000/-** for the due and faithful performance of his duties, within a month from the date of his appointment and produce the same before the Office.
