5. For the post of Court Assistant, the individual will be paid monthly honorarium of Rs.10,000/- per month, as per G.O. mentioned in the reference 4<sup>th</sup> cited.
6. The individuals are hereby informed that their services are liable to be terminated if their work is not satisfactory.
7. The present order will be reviewed if any modified orders are received from the Government or High Court.
