The Hon'ble High Court of Andhra Pradesh issued Notification vide No.10/2022-RC dated 21.10.2022 and invited on-line applications to fill up vacant posts of OFFICE SUBORDINATE in the unit of District Judge, Kadapa. The Hon'ble High Court conducted on-line examinations from 21.12.2022 onwards. The Hon'ble High Court in proceedings ROC No.19/2022-RC, dated 29.03.2023 and 12.07.2023 published the **First and Second lists** of candidates through on-line who provisionally selected to the post of OFFICE SUBORDINATEs and they are instructed to produce their original certificates and other documents before the Principal District Judge, Kadapa.

But, some of the candidates failed to appear for document verification during the said period and later submitted applications vide 12th to 15th references cited to consider their candidature and the same were forwarded to the Hon'ble High Court vide 18th reference cited.

The Hon'ble High Court addressed a letter vide 19th reference cited and directed to examine the documents, considering their medical grounds and give them appointment letters if the respective posts were still vacant. Accordingly, this Court issued Notice vide 21st reference cited and the individuals are directed to appear before the District Court, Kadapa along with their Original certificates for verification of their documents and supportive medical records for consideration.

The following provisionally selected candidates for the post of OFFICE SUBORDINATEs are appeared before the office of the Principal District Judge, Kadapa and submitted their original educational qualification certificates, Medical certificates, Revised Attestation Forms and other documents.

Having considering the medical certificates submitted by the individuals and also on perusing the original certificates and other documents of the individuals, the Principal District Judge, Kadapa is hereby issued orders appointing the individuals as **OFFICE SUBORDINATES** under Direct Recruitment in the existing vacancies on purely temporary basis subject to verification of the antecedents of the candidates and issued posting orders as noted in the table.
