- 4. After due verification and detailed examination, the Government of Andhra Pradesh hereby approve the selection of twenty (20) candidates specified in the Annexure to this order for appointment as Civil Judges (Junior Division) under Direct Recruitment nineteen (19) and Recruitment by transfer One (01), respectively.
- 5. Government hereby direct that the candidates shall undergo the prescribed period of training after executing bonds on their appointment as per rule 8 of the Andhra Pradesh State Judicial Service Rules, 2007. On completion of the prescribed training, they shall be appointed temporarily as Civil Judges (Junior Division).
