The Hon'ble Supreme Court of India in its Judgment, dated 04.01.2024 passed in Writ Petition (C) No. 643 of 2015 while approving the recommendations of the Second National Judicial Pay Commission has issued certain directions and the directive No.33(f) of the Judgment is :

"The judicial officers shall be permitted to exhibit a sticker at their option on the lower left side of the windscreen with inscription 'Judge' printed in moderately sized letters"

Therefore, in supersession of the circulars issued by the High Court in regard thereto, all the Judicial Officers are permitted to exhibit a sticker on the lower left side of the windscreen of the vehicle with inscription 'Judge' printed in moderately sized letters as per the directive No.33(f) of the Judgment of the Hon'ble Supreme Court of India.


