CIRCULAR

The Hon'ble High Court of Andhra Pradesh vide reference cited, has issued certain instructions to all the Judicial Officers with regard to use of BLUE INK instead of Green Ink when recording Depositions/ Statements of Parties, Accused or Witnesses as the case may be, in Civil and Criminal cases.

It has been brought to the notice of the undersigned that inspite of circular instructions of the Hon'ble High Court, some of the Judicial Officers are not following the above said Circular instructions and used to sign with the Green Ink when recording Depositions/ Statements of Parties, Accused or Witnesses as the case may be, in Civil and Criminal cases.

Therefore, all the Judicial Officers in Kadapa District Unit are hereby directed to follow the circular instructions issued by the Hon'ble High Court of A.P. scrupulously and they are further directed to use BLUE INK instead of Green Ink when recording Depositions/ Statements of Parties, Accused or Witnesses as the case may be, in Civil and Criminal cases.

Certain instances have come to the notice of the High Court that some of the Judicial Officers in the State are recording depositions/Statements of the Parties, Accused or witnesses as the came may and a GREEN INK, in Civil as well as in Griminal cases.

Whenever the copies of such Depositions/Statiments are taken for the use of the High Court on Xerox machines, the impression of the Xerox copies is not clear and visible.

Hence, all the Judicial Officers in the State are hereby instructed to use only BLUE INK instead of Green Ink when recording Depositions/Statements of Parties, Accused or Witnesses as the cse may be, in Civil and Criminal cases.
