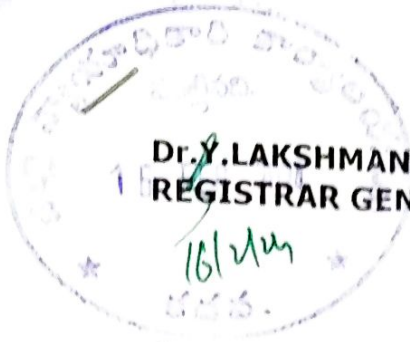

**ADVERTISEMENT**

Online applications are invited from eligible Advocates to fill up 83 vacancies (SC-17, ST-01, OBC-22, EWS-08 and Unreserved-35) of Direct Recruitment to Uttar Pradesh Higher Judicial Service - 2023, (Revised Pay Scale-Rs. 144840 - 194660).

1. **Practice:** An advocate candidate must be a person not already in the service of the Union or of State and has been for not less than seven years an advocate having continuous practice.

2. **Age:** A candidate must have attained the age of 35 years and must not have attained the age of 45 years as on 01.01.2024, i.e. the candidate must have been born on or after 02.01.1979 and not later than 01.01.1989. Age limit shall be higher by 03 years in case of SC/ST/OBC category candidates belonging to the State of U.P. only (a candidate of SC/ST/OBC category must have attained the age of 35 years and must not have attained the age of 48 years as on 01.01.2024, i.e. the candidate must have been born on or after 02.01.1976 and not later than 01.01.1989).

3. **Reservation:** There shall be 20% horizontal reservation for women subject to final decision in Special Appeal No. 675 of 2019 and its connected Special Appeal filed against the order dated 16.01.2019 of this Court passed in Writ Petition No. 11039/2018 - Vipin Kumar Maurya and Ors. Vs. State of U.P. and Ors. and its connected Writ Petitions, wherein Clause (4) of G.O. Dated 09.01.2007 was declared ultra vires. 04% horizontal reservation will be provided to the Differently abled candidates as per the provisions given in the U.P. Higher Judicial Service Rules, 1975. The aforesaid horizontal reservation will be provided in a compartmentalized manner.

Reservation for SC/ST/OBC/EWS/PwD categories will be applicable for the candidates belonging to the State of U.P. only.

4. **Submission of Application Form:** The application shall be submitted online from 15<sup>th</sup> January, 2024 to 29<sup>th</sup> February, 2024 till 23:59 hours after which the link will be disabled. Applications received through any other mode will not be accepted. {Official website: ([www.allahabadhighcourt.in](http://www.allahabadhighcourt.in))}.

Dates for submission of Hard Copy of online filled in Application Form will be notified in due course.

5. **Preliminary Examination:** The Date of Preliminary Examination will be notified in due course.

6. **Examination Fee:**

Rs. 1400/-	For General/OBC/EWS category candidates.
Rs. 1200/-	For SC/ST category candidates belonging to State of U.P. only.
Rs. 750/-	For PwD category candidates of General/OBC/EWS category belonging to the State of U.P. only.
Rs. 500/-	For PwD category candidates of SC/ST category belonging to the State of U.P. only.
Rs. 1400/-	For all the candidates belonging to the States other than State of U.P.

**Note-I** The number of vacancies of Direct Recruitment to U.P. Higher Judicial Service-2023, so advertised, are **Provisional** and may vary (increase or decrease).
