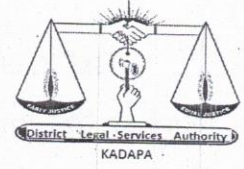

Pursuant to the certain directions given by the Hon'ble Supreme Court of India under reference 2nd cited above, a monitoring committee is hereby constituted at District level for YSR Kadapa District to deal the applications of the claimants in Motor Vehicle hit and run cases to decide who the rightful claimants are to claim the compensation.

A monitoring committee comprising of :

1. Secretary, District Legal Services Authority, Kadapa – Convener.
2. Sri K. Ravi Kumar, Deputy Superintendent of Police, DTC, YSR Kadapa District – Claims Enquiry Officer.

The monitoring committee shall meet atleast once in every two months to monitor the implementation of the scheme in the District and the compliance of the directions of the Hon'ble Supreme Court of India.
