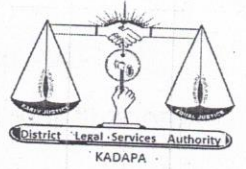

A monitoring committee comprising of :

2. Sri P. Sreedhar, Deputy Superintendent of Police, CCS, Annamayya District – Claims Enquiry Officer.

The monitoring committee shall meet atleast once in every two months to monitor the implementation of the scheme in the District and the compliance of the directions of the Hon'ble Supreme Court of India.
