- 1. The above individuals are hereby informed that their promotions to the post of Junior Assistant (Category-08) are made purely on temporary basis and they are liable to be reverted at any time without prior notice and without assigning any reasons and donot give them any preferential claim for future promotions.
- 2. The above individual viz. **S.No.2 Smt P. Sakunthala** is promoted as **Junior Assistant**. As per Orders of Hon'ble High Court of A.P. in **W.P.No.953/2021**, **12959/2019 and 23411/2020**, though the individual is having less than 3 years of service, she is permitted under **Rule 35(b) of APJMSS Rules**, **2019** and also **as per the Circular of the Hon'ble High Court in R.O.C.No. 1060/2022-C1, dated 18.10.2022** to acquire the Degree within 05 years from the date of her promotion failing which, consequences do follow.

As per Orders of the Hon'ble High Court in the above Writ petition, the individual **Smt P. Sakunthala** is promoted to the post of Junior Assistant subject to acquiring the Bachelor's Degree qualification within 05 years from the date of Promotion (Rule 35(b) of APJMSS Rules, 2019) failing which, the consequences as per Orders of the Hon'ble High Court in the above writ petitions would follow.

- 3. The promotion of **S.No.4** viz., Smt G. Lalitha Kumari, Record Assistant is subject to result of Departmental Enquiry vide **D.E.No. 01/2007.**
- 4. The above individuals shall deposit security for an amount of **Rs.10,000/-** in the shape of FDR duly pledging the same in favour of the Principal District Judge, Kadapa, within 30 days from the date of his/her joining in the promotion post, **as per Rule 22 of APJMSS Rules, 2019.**
- 5. The above individuals are hereby directed to relive and join in the promotion posts on or before 28.03.2024.
- 6. The Judicial Officers under whom the above members are working and promoted shall instruct for necessary arrangements for handing over and taking over charge with all pending work lists.
- 7. The Officers concerned are requested to relieve the individuals, invariably, without any request.
- 8. If any of the above persons is on Earned leave/ Medical leave/ C.L. shall join the new place immediately on completion of their respective leaves, without fail.
- 9. The Order placed in the <u>districts.ecourts.gov.in/Kadapa</u> and the downloaded copy from the website is valid for relieving and joining duty.
