The departmental officers in the feeder grade who are in direct line of promotion shall not be eligible 3 for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointments by promotion channel.

The maximum age limit for appointment by deputation shall not exceed 56 years with a residual 4. service of four years on the closing date of receipt of applications.
