The Principal District Judge, Kadapa, is pleased to pass the following:



Further, the individuals mentioned in Column No.2 are directed to hand over the charge of their post to the immediate next juniors of their respective posts, and after relieving proceed to their new stations/ posts and take charge of their respective posts.

5. The Presiding Officers concerned are requested to relieve the individuals, invariably, without any request.
6. One post of Senior Assistant in Principal Civil Judge's Court (Senior Division), Rajampet, V Additional District Judge's Court, Rayachoty and Civil Judge's Court (Junior Division), Railway Kodur are kept vacant.
