In pursuance to the subject and references cited above, the undersigned is pleased to pass the order as following:-

It is to submit that Hon'ble High Court has developed an application Statistical Hub online web portal (<https://aphc2.in/stathub>) for furnishing monthly statistics to the High Court by the lower courts from all the Districts. It is to inform that the statistical data which was submitted through STAT HUB by all the courts from the respective districts from MAY 2024 to NOV 2024 is enabled for editing and resubmitting as per the available category of cases in their respective courts.

In pursuance to the Hon'ble High Court directions and the undersigned instructions, a training programme is scheduled on **23.12.2024 at 4 PM to 4.30 PM** to all the Administrative Officers/ CMOs/ Superintendents, bench clerks, typists and all concerned staff dealing with monthly statistics data in the Kadapa District.

All the Judicial Officers are requested to direct the above individuals working in your respective presiding courts to attend the said training programme along with the copy of **list of new computer codes** in the given schedule as attendance will be taken.

As this resubmission of statistical data from MAY 2024 to NOV 2024 as per the new and old computer codes allotted to the various category of cases is time

bound (editing option in STAT HUB will be disabled by Hon'ble High Court by 28.12.2024) and in view of urgency and less time period, all the Judicial Officers are requested to **not to grant any type of leaves** to the ³¹³above concerned until completion of above data entry in STAT HUB application.
