



- Make use of the services of PLVs to spread awareness about the ensuing National Lok Adalat
- Conduct Pre-Lok Adalat sittings on daily basis.
- The Chairpersons of DLSAs shall ensure reference of cases to the Chairmen of PLAPUS concerned and also ensure conducting Pre Lok Adalat Sittings by the Chairman, PLAPUS on daily basis.
- The Judicial Officers of your respective district be appraised for identification and reference of cases to National Lok Adalat
- Every care shall be taken while drafting awards and shall cause verification of details of parties, description of property and other significant issue so as to avoid further litigation.
- Conduct periodical meetings in physical or virtual mode to ensure participation of the party advocate in the Pre Lok Adalat sittings so as to arrive settlement in the matter.

All the Chairpersons of DLSAs are requested to take special attention for settlement of good number of pending cases in the ensuing National Lok Adalat to be held on **08-03-2025 (Second Saturday)**.
