I. Qualifications:-

A person:

- 1. Must be below 65 years of age.
- 2. Who has held a post in the Andhra Pradesh Judicial Ministerial Service and retired from service is eligible for the post of Court Assistant.
- **3.** Who has held a post in the A.P.L.G.S. and A.P.G.S.S. and retired from service is eligible for the post of Court Attendant.
- 4. who has at least one year to complete 65 years as on the date fixed by the Court in the year of recruitment, shall alone be eligible.

II. Disqualifications:-

- 1. Persons who have been dismissed or removed from service or compulsorily retired from service or subjected to any other major penalty and misconduct are not eligible to apply.
- 2. Persons who have been convicted and sentenced by a Court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude and proceedings are pending are not eligible to apply.
- 3. Persons of unsound mind or deaf or mute or blind or suffering from leprosy or any other contagious diseases are not eligible to apply.
- 4. Persons who have been adjudicated as an insolvents or undischarged insolvents are not eligible to apply.

III. REVOCATION OF POWERS OF COURT ASSISTANT AND COURT ATTENDANT:-

- On appointment and while in service a Court Assistant or Court Attendant may be removed without being called upon to show cause if he/ she fails to attend the Office without written permission of the Special Judicial Second Class Magistrate.
- Powers conferred by the Court on the Court Assistants and Court Attendants shall automatically stand withdrawn on his attaining the age of 65 years.

IV. WORKING CONDITIONS:-

The individual is entitled to avail Casual leave not exceeding 15 days in an year but not to any other kind of leave.

V. ATTESTED COPIES OF DOCUMENTS SHOULD BE ENCLOSED TO THE APPLICATION:-
