The Hon'ble High Court of Andhra Pradesh issued Notification vide No.4/2025-RC dated 06.05.2025 and invited on-line applications to fill up vacant posts of Field Assistant in the unit of District Judge, Kadapa. The Hon'ble High Court conducted on-line examinations from 20.08.2025 to 24.08.2025 onwards. The Hon'ble High Court in proceedings ROC No.72/2025-RC, dated 31.12.2025 published the list of candidates through on-line who provisionally selected to the post of Field Assistants and they are instructed to produce their original certificates and other documents before the Principal District Judge, Kadapa from 19.01.2026 to 23.01.2026.

The following provisionally selected candidates for the post of Field Assistants are appeared before the office of the Principal District Judge, Kadapa and submitted their original educational qualification certificates, Revised Attestation Forms and other documents.

On perusing the original certificates and other documents of the individuals, the Principal District Judge, Kadapa is hereby issued orders appointing the individuals as **Field Assistants** under Direct Recruitment in the existing vacancies on purely temporary basis subject to verification of the antecedents of the candidates and issued posting orders as noted in the table.

1. The above individuals are hereby directed to produce Physical Fitness Certificate in the prescribed proforma obtained from not below the rank of Civil Assistant Surgeon, at the time of joining duty.
2. The above individuals are hereby informed that their appointment is purely on temporary basis and is liable to be terminated at any point of time, without prior notice or without assigning any reason.

3. The individuals are hereby directed to produce one set of Photostat copies of educational qualification certificates at the time of joining duty before the Presiding Officer of the Court, where the individual is posted for verification before the Presiding Officer of the Court.
4. The individuals are hereby informed that they shall join the duty of his/her post at the given station on or before **09.02.2026**, otherwise, the orders will be invalidated.
5. The above said individuals are informed that they will be governed under the **CONTRIBUTORY PENSION SCHEME** only as per G.O.Ms.No.653, 654 & 655 Fin (Pen-I) Dept, dated 22-9-2004.
6. As per amended APJMSS Rules issued in G.O.Ms.No.76 Law (L,LA&J Home Courts.A) Department, dated 15-05-2019, all the individuals have to deposit security to an amount of **Rs.10,000/-** for the due and faithful performance of his/her duties, within a month from the date of his/her appointment and produce the same before the office.
7. The above individuals are hereby informed that their selection and appointment to the post of Field Assistant will be subject to the verification of their antecedents.
8. The candidates are informed that if at all the documents produced by the candidates are found to have been created, manipulated, interpolated or forged in future date, they would be removed/dismissed from service besides launching criminal prosecution against them.
9. The candidates in the above proceedings who are now working in other Departments, are directed to submit Relieving/Resignation Certificate from their employer and submit the same in Principal District Court, Kadapa before joining duty.
10. The candidates are further informed that their seniority will be fixed at a later date, as per the guidelines of the Hon'ble High Court.
