## **ANNEXURE-I**

## **GENERAL TERMS AND CONDITIONS**

#### (A) INSTRUCTION TO BIDDERS

- The interested tenderer must superscribe the words "TENDER FOR SUPPLY OF FURNITURE" (in bold capital letters) on the sealed cover while submitting the tender and should be addressed to "Registrar, Civil Courts, Berhampur".
- 2. The aforesaid tender should be dropped into the Tender Box kept in the Process Establishment Section, District Court, Berhampur or the same will be received through registered Post/Speed Post up to 04:00 P.M. of 14.02.2023. The bids sent through E-mail shall not be acceptable. The bids will not be accepted beyond the schedule date and time.
- The sealed tenders enclosing the offer letter as per the proforma in Annexure-II & III along with required documents should reach this office by 04.00 P.M. on 14.02.2023. The bids received after the stipulated time shall also be summarily rejected.
- 4. The received sealed tenders will be opened on **14.02.2023 at 04.30 P.M**. in presence of the Competent Authority, available tenderers or their authorized agents. The authorized representative (only one person per bidder) will be permitted to remain present at the venue of opening of bids.
- 5. The Bids shall be rejected, if information given therein is found to be false, incorrect or incomplete in any manner whatsoever at any stage prescribed in the tender. Should any ineligibility detected, then no correspondence thereof shall be entertained.
- 6. The Authority shall not be responsible for any delay in submission of bids and later bids shall summarily be rejected.
- 7. The tender form is non-transferable.
- 8. The bidder shall have valid GST registration certificate and latest GST filing report if any.
- 9. The bidder shall have a firm registration.
- 10. The bidder shall have valid PAN card.
- 11. Rate quoted shall be inclusive of all taxes and charges if any and deliverable at District Court, Berhampur, Ganjam. The Authority will not pay any extra charge for transportation of the products to its campus.
- 12. The selection shall be on basis of price quoted for the same subject to verification of required documents and specifications of the articles as called for. Any deviation in quality of supplied item from the approved sample shall lead to penalty or termination of the rate contract or both.
- 13. The E&PM rate contract suppliers supplying for articles registered under Directorate of E&PM, Odisha will be given preference, subject to availability and validity of E&PM rate contract.
- 14. The delivery of the articles should be completed within 15 days of award of tender.
- 15. **Payment:** No advance payment will be made by the Authority inviting tender. However, Part/Full Payment shall be made after complete delivery of articles and after due inspection by the Authority.
- 16. The authority reserves the right to cancel any or all bids without assigning any reason.
- 17. The decision of the District Judge, Ganjam on any disputes arising out of the bidding process or during the execution of the work shall be final and binding.

#### (B) DOCUMENTS TO BE SUBMITTED ALONG WITH THE TENDER:

Sealed Cover must contain the following documents, failing which the bid will be summarily rejected.

- 1. EMD and offer price in the manner specified in Annexure-II in the Notice for Invitation of Bids.
- Self-attested copy of GST Registration Certificate of the firm and latest GST filing report, if available.
- 3. Self-attested copy of PAN card of the firm/bidder issued under Income Tax Act.
- 4. Self-attested copy of Valid Registration No. of the Agency/Firm.

#### (C) ELIGIBLITY CRITERIA FOR BIDDERS

- 1. The bidder must not have been black listed by any Central or State Govt. Institution. The bidder must furnish an affidavit duly sworn in before the Notary Public in this regard along with the bid documents.
- 2. The bidder must have valid service tax registration certificate, PAN card GST certificate and in case of a company, it must have a valid certificate of incorporation.

#### (D) TERMINATION FOR DEFAULT

- 1. The Authority inviting bids may without prejudice to any other remedy for breach of contract, by short written notice of default sent to the contractor, terminate this contract in whole or in part,
- 2. If the successful bidder found to have made any misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- 3. If record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc. found; and/or
- 4. If the contractor is indulged in any unlawful & corrupt means in obtaining bids.
- 5. If being blacklisted their registrations by the competent authority.

#### (E) EMD/ BID SECURITY

- 1. The Bid must be accompanied by an Earnest Money Deposit (EMD) of Rs.1,000/- (Rupees One Thousand) only by way of Demand Draft from any Nationalized Bank in favour of "Registrar, Civil Courts, Berhampur" payable at "Berhampur".
- 2. The Bid shall be declared non-responsive and shall be rejected if submitted without an acceptable EMD/Bid Security.
- 3. The bid Security of unsuccessful bidders will be returned within 15 days from the date of finalization of the tender.

#### (F) THE BID SECURITY MAY BE FORFEITED

- 1. If the bidder withdraws the bid after opening of the bid but within the period of validity.
- 2. If the Bidder seeks any revision of rates or backs out of the bid claiming for not having referred to any or all documents provided in the Bid by the Officer inviting the Bids.
- 3. If the Bidder fails to submit the original documents with in the stipulated date pursuant to clause 2.

#### (G) VALIDITY OF THE TENDER

- 1. The tender shall remain valid for a period of 30 days from the date of opening of the tender.
- 2. The tenderer/bidder shall sign at the bottom of each page of the tender documents.

#### (H) PROCESS TO BE CONFIDENTIAL

Information relating to the examination, clarification, evaluation and comparison of bids and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process until the award to the successful bidder has been announced. Any effort by a bidder to influence the officer inviting the bid, processing of bids or award decisions may result in the rejection of his bid.

#### (I) AWARD CRITERIA

- 1. The contract will be awarded to the bidder whose bid has been determined to be substantially responsive to the bidding documents and who has offered the lowest evaluated price.
- 2. Competent Authority i.e. the District Judge, Ganjam reserves the right of accepting the whole or any part of the bid and the bidder shall be bound to perform the same at the rate quoted.

#### (J) OPENING AND EVALUATION

Bid opening dates have been specified in the Notice for Invitation of Bids or can be extended vide corrigendum.

## (K) FORCE MAJEURE

If any time, during the continuance of this contract, the performance in whole or in part by either party under obligation as per this contract is prevented or delayed by reasons of war or hostility, act of the public enemy, civil commotion, sabotage, fire, flood, explosion, epidemic, quarantine restrictions, strike, lockout or acts of nature, hereinafter referred to "eventuality", provided notice of happening of any such eventuality is given by either party to the other within 21 days of the date of occurrence thereof, neither party shall be reason of such an "eventuality" be entitled to terminate this contract nor shall either party have any claim or damages against the other in respect of such non- performance or delay in performance and deliveries under the contract. The contract shall be resumed as soon as practicable after such "eventuality" has come to an end or ceased to exist. In case of any dispute, the decision of the District Judge, Ganjam at Berhampur, shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such, eventuality for a period exceeding 30 days, either party may at its option, terminate the contract provided also that if the contract is terminated under this clause the Purchaser shall be at liberty to take over from the Contractor at a price to be fixed by the Purchaser, which shall be final, all unused, undamaged and acceptable materials, brought out components and other stores in the course of manufacturer which may be in the possessions of the Contractor at the time of such termination, or such portion thereof as the Purchaser may deem fit except such material as the Contractor may, with the concurrence of the Purchaser, elect to retain.
