- The PLVs should have mind set to extend voluntary service to the down trodden people SC/ST/ Child/ Women/ Senior Citizen and all marginalized section of the society who are unable to get justice and right out of their poverty and ignorance without expectation of monetary gain from it.
- Para Legal Volunteers should have a mind set to assist the needy in the society coupled with the compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society.
- They must have unflinching commitment towards the cause which should be translated into the work they undertake.

- The work of the PLVs does not carry any salary, remuneration of wages except honorarium fixed by the DLSA from time to time.
- The PLVs shall be disqualified and removed from the panel if he/she fails to evince interest in the scheme, has been adjudged insolvent, has been accused of an offence, has become physically or mentally incapable of acting as PLVs, has abused his/her position or misconducted in any manner as to render his/her continuance prejudicial to the public interest.
